Whether Digital Cookie is a Girl Scout's primary method of selling or not, all Girl Scouts are encouraged to login and set up their sites with their parents to manage the 2023 Cookie Program! Yeah! Your Girl Scout is receiving orders! Parents must [approve in-person delivery orders](#) within 5 days or the order may be cancelled. Notification emails are sent to parents overnight after the date of the order for any unapproved orders. If a parent approves an order on the same day it was placed, no notification email will be sent.

Offline/paper orders can be added to a Girl Scouts total sales on the Digital Cookie dashboard so it accurately reflects her progress. On the dashboard under Packages Sold, click on UPDATE to add offline/paper orders.

The Digital Cookie Mobile app is a great sales tool, but remember it is ONLY a sales tool! Girl Scouts with their parent cannot manage her Digital Cookie site from the app.

As [emailed](#) on November 30, 2022, the ability for customers to place a Digital Cookie shipped order will not be available until Monday, February 27, 2023. This includes the ability to purchase the new Raspberry Rally cookie.
