If your Girl Scout reached a reward level of 650 packages or more, she needs to make a reward choice. Please notify the Troop Cookie Chair of this choice as soon as possible, but no later than Tuesday, March 21.

If your Girl Scout earned Cookie Dough or S'more Dough from the 2022 Cookie Program or Cashew Cash or S'more Dough from the 2021 Fall Product Program, it expires April 1, 2023. If not already used, please visit a GSNI store or use towards a GSNI program before it expires!

Deadline to submit entries for [Cookie Business Challenge](#) and [Multi-Girl Scout Family Rewards](#) (Sister Rewards) is Monday, March 27.

Digital Cookie shipped orders may be placed through Sunday, March 19. Pop-up Challenges include [Digital Cookie shipped packages by Girl Scout](#) and [Digital Cookie shipped packages by Troop Link](#) for Digital Cookie shipped packages sold February 27-March 19.

Troops and Girl Scouts that are interested in picking up Gift of Caring (donation) cookies to donate to local organizations, first responders, military organizations, food pantries, essential businesses, etc. may schedule pick up times from a council cupboard March 30-April 4. Please email [cookies4you@girlscoutsni.org](mailto:cookies4you@girlscoutsni.org) with your troop number, how many cases you would like to pick up, preferred date/time of pick up and where donating. After donating, complete the [GOC Delivery form](#) by Monday, April 24 and Girl Scouts in the troop will receive the Shoe charm.

Over 1,200 Girl Scouts qualified from the 2022 Fall Product Program, to earn the [Fall & Cookie Crossover Personalized Patch](#). To earn the patch, during the 2023 Cookie Program these Girl Scouts must send 18+ unique emails through Digital Cookie and sell 225+ total packages of cookies. Any [edits to a Girl Scouts avatar](#) must be completed by Wednesday, March 22, 2023.
