If your Girl Scout has reached a reward level with a choice, please **notify the Troop Cookie Chair now which reward your Girl Scout has chosen.** *The troop deadline to submit rewards is Tuesday, March 24.*

Cookie Cravers offer a convenient way for Girl Scouts and their parents to continue taking orders independently, without needing help from the Troop Cookie Chair. Simply fill out the [Cookie Craver order card](#) to collect additional orders, then bring a completed [Cookie Craver submission form](#) to a [council cupboard](#) to pickup the needed cookies. Payment is due at the time of pickup, and council will make sure the Girl Scout and troop receive the appropriate credit for the sales. Please note that Digital Cookie orders cannot be processed through Cookie Cravers. **The final day to submit Cookie Craver orders is March 21.**

It's going to be a beautiful weekend to round out the cookie season. If your troop still has inventory, there are still **council booth** spots open or do a Walkabout around your neighborhood! Help us fill those spots so we have booths to visit. Let's finish this season strong!

When a Girl Scout sells a case (12 packages) or more to **three or more businesses**, she earns the Cookie Business Challenge patch.
