Look for a registration email from email@email.girlscouts.org and be sure to check your promotions, spam, or junk folders. If you still can't find it, refer to the [No Registration Email](#) tip sheet or contact council at cookies4you@girlscoutsni.org for assistance. Orders placed through Digital Cookie by Sunday, January 19, will count toward the Initial Order. *That's not the end of Digital Cookie and Girl Scouts taking orders!* Girl Delivery orders can continue to be taken through Monday, March 3, and shipped or donation orders can continue to be taken through the end of the program on Sunday, March 9. Once your Girl Scout's Digital Cookie site is live, use the [Digital Cookie Mobile App](#) for quick and easy order-taking. The app even provides a [QR code](#) that your Girl Scout can use to promote her Cookie Business in creative ways!
