

Multi-Girl Scout Family Special Reward Offers 2024 Cookie Program



Family Requirements

- Two or more Girl Scouts in the same family must be participating in the GSNI 2024 Cookie Program.
- Girl Scouts must live in the same household (full or part-time).
- Girl Scouts do not have to be in the same troop.
- Parent or Troop Leader/Cookie Chair **MUST complete the Multi-Girl Scout Family Special Reward form**, if they choose to take advantage of any special reward offer **by Monday, March 18**. Special Reward – unique “Sister” patch

- Girl Scouts must meet the family requirements above.
- Two Girl Scouts in the family must sell a total of 300 packages of cookies and one of the Girl Scouts must sell a minimum of 135 packages.
- For each additional Girl Scout in the family, an additional 135 packages must be sold, and each Girl Scout must sell a minimum of 135 packages.
- Number of packages sold must be listed in eBudde™ as described.
- Participating Girl Scouts do not all have to be taking rewards. One or all Girl Scouts’ troops may opt-out of rewards and still receive the unique “Sister” patch.
- For all other rewards, Girl Scouts (that do not opt-out) will only receive the rewards earned based on the actual individual packages sold as listed in eBudde™.



Special Reward Offer for Seller-bration events

- Girl Scouts must meet the family requirements above.
- Two Girl Scouts in the family must sell a total of 750 packages of cookies and one of the Girl Scouts must sell a minimum of 250 packages.
- For each additional Girl Scout in the family, an additional 250 packages must be sold, and each Girl Scout must sell a minimum of 250 packages.
- Number of packages sold must be listed in eBudde™ as described.
- Girl Scouts must attend the age-appropriate Seller-bration event (Super Seller-bration for DA/BR/JR – Saturday, June 1, High Adventure Seller-bration for CAD/SR/AMB – Sunday, May 18). If attending the same event two parents/adults may attend (no other siblings or children may attend). If three or more Girl Scouts in the family meet the requirements, no additional adults or siblings/children may attend. Maximum of two adults. Only Girl Scouts that earned the reward may attend.
- Participating Girl Scouts do not all have to be taking rewards. One or all Girl Scouts’ troops may opt-out of rewards and still receive this special reward offer.
- For all other rewards, Girl Scouts (that do not opt-out) will only receive the rewards earned based on the actual individual packages sold as listed in eBudde™.

Special Reward Offer for Walt Disney World or Universal trip

- Girl Scouts must meet the family requirements above.
- For the 3,500+ package level, two Girl Scouts must sell a total of 5,500 packages of cookies and one of the Girl Scouts must sell a minimum of 2,750 packages of cookies.
- At the 3,500+ package level, for each additional Girl Scout in the family an additional 2,750 packages must be sold and each Girl Scout must sell a minimum of 2,750 packages.
- Number of packages sold must be listed in eBudde™ by girl as described.
- Both Girl Scouts may attend the trip with one parent/adult. For an additional parent/adult to attend, the second Girl Scout must also sell 3,500 packages of cookies or additional parents/adults and/or siblings/children may pay for their portion of the trip. - Participating Girl Scouts must all be taking rewards. No Girl Scouts may opt-out of rewards and receive this special reward offer.
- For all other rewards, Girl Scouts will only receive the rewards earned based on the actual packages sold, as listed in eBudde™, and will not receive any other non-cumulative rewards listed on the order card.
